SCHOOL FEES:

The monthly school fees amount to R5850.00 (five thousand eight hundred and fifty rands) payable monthly by the **15th of each calendar month**.

LATE PAYMENT LEVY:

A late payment levy of R50.00 will be charged on accounts for fees not paid by the 15th of the month. This amount will reflect on the following month's account.

MATERIAL LEVY:

A material levy is payable at the beginning of each calendar year. This amount may be apportioned should the student join the school later during any year.

ADMINISTRATION FEE:

A once-off administration fee is payable upon enrolment of the student.

HOURS:

The school will be open during the hours of **7.45am and 12.30pm** each school day during the term. Late pick-up will be charged for.

TERMS:

The school terms are run on a three-term calendar.

NON-ATTENDANCE BY THE PUPIL:

No discount or refund shall be given or afforded should a pupil not attend school for whatever reason.
